Licensure v. Certification

Certification is a voluntary process, by a private organization, and provides information to the public about people who have completed the certification process. It is not necessary for a person to practice their job. For instance, a physician does not need to be certified to practice, but it may provide more information about the physician and their credibility.

Licensure is the state's grant of legal authority to practice a profession within a designated scope of practice.

- In order to apply you need the following documentation: experience documentation forms, training documentation forms, letters of authenticity, official transcripts verifying the appropriate degree, official certificates of training, and foreign transcript evaluations. - **Academy of Cognitive Therapy:** Cognitive Behavioral Therapy (CBT) Certification. This certification is awarded to individuals who have demonstrated an advanced level of expertise in cognitive therapy. - **Moral Reconciliation Therapy (MRT):** “seeks to decrease recidivism among both juvenile and adult criminal offenders by increasing moral reasoning. MRT is systematic and implements a cognitive-behavioral approach, which positively addresses an adolescent’s ego, social, moral, and positive behavioral growth.” <http://www.ncjfcj.org/moral-reconciliation-therapy-mrt>

Registered Respiratory Therapist

- Information about how to become registered: “Graduates of accredited advanced level education programs will have three years after graduation to earn the RRT credential. Individuals who do not earn the RRT credential within this time limit will be required to retake and pass the Therapist Multiple Choice Examination at the CRT cut score to regain eligibility, and any previous passing performance to earn the RRT credential shall be nullified.” <https://www.nbrc.org/rrt/pages/default.aspx>
